**Text:** *CCNA Routing and Switching Study Guide* by Todd Lammle, Sybex, 2013, ISBN 978-1-118-74961-6

This course covers the principles of local area network (LAN) technologies including protocols, hardware, LAN software and design concepts. The course will focus on the lower layers of the OSI model and explore Ethernet, bridging/switching, VLANs, securing the network and overview of Spanning-tree protocols. Basic routing using RIP and OSPF as well as WAN services will also be investigated. The course will involve multiple lab exercises and troubleshooting activities to help reinforce the concepts.

Required coursework components and their contribution to the final grade will be:

- a) 4 Homework Assignments (35%)
- b) 3 Lab Exercises (30%),
- c) Midterm exam (15%)
- d) Final Exam (20%)

Further details on each assignment will be distributed in class. Final grades will be calculated as follows: points earned divided by possible points in each category will be multiplied by the contribution percentages shown to yield a total course percentage score between 0% and 100%. Letter grades will be assigned as:

A = 90% - 100%	A- = 88% - 90%	B+ = 86%-88%	B = 80% - 86%
B- = 78% - 80%	C+ = 76% - 78%	C = 70% - 76%	C- = 68% - 70%
D+ = 66% - 68%	D = 60% - 66%	F = 0% - 60%	

Some assignments will not be accepted late – this will be marked on the assignment. Any other assignments received late will be penalized as follows: up to 1 day late is 15% penalty; between 1 day and 3 days late is 25% penalty; between 3 days and 6 days late is 40% penalty; no assignments will be accepted more than 6 days past the due date.

Homework assignments are due by 5:45PM on the due date. Lab assignments are due by 11:59PM on the due date.

Homework assignments, labs and exams must be completed individually unless the assignment explicitly states that team work is permissible. Class attendance is essential since lectures may cover topics outside the text.

#### **Online Course Evaluations**

### **Withdrawal**

Students who withdraw from the course do so by using the Campus Connection system (<http://campusconnect.depaul.edu>). Withdrawals processed via this system are effective the day on which they are made. Simply ceasing to attend, or notifying the instructor, or nonpayment of tuition, does not constitute an official withdrawal from class and will result in academic as well as financial penalty.

### **Retroactive Withdrawal**

This policy exists to assist students for whom extenuating circumstances prevented them from meeting the withdrawal deadline. During their college career students may be allowed one medical/personal administrative withdrawal and one college office administrative withdrawal, each for one or more courses in a single term. Repeated requests will not be considered. Submitting an appeal for retroactive withdrawal does not guarantee approval. College office appeals for CDM students must be submitted online via MyCDM.

### **Incomplete**

An incomplete grade is a special, temporary grade that may be assigned by an instructor when unforeseeable circumstances prevent a student from completing course requirements by the end of the term and when otherwise the student had a record of satisfactory progress in the course. CDM policy requires the student to initiate the request for incomplete grade before the end of the term in which the course is taken. Prior to submitting the incomplete request, the student must discuss the circumstances with the instructor. Students may initiate the incomplete request process in MyCDM.

- All incomplete requests must be approved by the instructor of the course and a CDM Associate Dean. Only exceptions cases will receive such approval.
- If approved, students are required to complete all remaining course requirement independently in consultation with the instructor by the deadline indicated on the incomplete request form.
- By default, an incomplete grade will automatically change to a grade of F after two quarters have elapsed (excluding summer) unless another grade is recorded by the instructor.
- An incomplete grade does NOT grant the student permission to attend the same course in a future quarter.
