

CSC 398 - Internship

Summary

The CSC 398 Internship class offers students the opportunity to receive on-the-job training that is related to their degree program at DePaul. **IMPORTANT:** This class DOES NOT count for LSP Experiential Learning Credit.

Enrollment/Application

Students cannot register for CSC 398 directly, but instead must apply for the course through myCDM by clicking on the “MyInternships” link. After completing the application admission to the internship program requires consent of the Instructor and a Student Services Advisor. In particular, the internship position must be related to the student’s degree program and the application must meet all other program requirements (see below). International students may require additional approvals.

Credit hours

CSC 398 is offered for variable credit, anywhere from one to four credits per term. The course may be repeated for a maximum of four credits total. At a minimum a student must work 25 hours for each 1 credit received. For example, in order to register for 4 credits during a 10 week academic quarter, a student must average at least 10 hours of work per week.

Non-transfer

A student’s registration for CSC 398 is attached to the internship position stated on the application. A student *cannot* switch/transfer this registration to another internship position at any time after the application is made. In the event that a position is eliminated or significantly modified, the student should contact the instructor *immediately* to discuss options.

Grading

The course grade will be based on 1) level of performance and successful completion of the position’s responsibilities as evaluated through a written evaluation by the internship’s supervisor, 2) a weekly log of activities/hours recorded by the student, and 3) a report written by the student that details the work performed and its relation to the student’s academic program within CDM.

School policies:

Online Teaching Evaluation

Evaluations are a way for students to provide valuable feedback regarding their instructor and the course. Detailed feedback will enable the instructor to continuously tailor teaching methods and course content to meet the learning goals of the course and the academic needs of the students. They are a requirement of the course and are key to continue to provide you with the highest quality of teaching. The evaluations are anonymous; the instructor and administration do not track who entered what responses. A program is used to check if the student completed the evaluations, but the evaluation is completely separate from the student's identity. Since 100% participation is our goal, students are sent periodic reminders over three weeks. Students do not receive reminders once they complete the evaluation. Email

Email is the primary means of communication between faculty and students enrolled in this course outside of class time. Students should be sure their email listed under "demographic information" at CampusConnect is correct.
