COURSE DESCRIPTION:

This class focuses on rewriting the feature film screenplay. Through group workshops and course discussions, students will learn how to identify missteps in their writing and develop a practical means to efficiently address these issues moving forward. Students must possess a complete feature-length script in order to enroll in the course.

This class focuses on practical ways to approach the rewriting process for feature film screenplays. Through group workshops and assignments, students isolate issues with plot, character development, dialogue and pacing in their script and work on addressing them in a full draft rewrite.

COURSE OUTCOMES:

Students will complete a rewrite plan and a full rewrite of an existing original feature screenplay.

LEARNING OBJECTIVES:

Upon successful completion of this course students will be able to:

- Organize and assess script feedback from their peers and the professor
- Devise a detailed plan for a comprehensive rewrite
- Revise their screenplay at a professional pace
- Evaluate the work of their peers and formulate helpful feedback

Self-Critique

Re-read your current draft in one sitting. Give yourself notes. Download the Self Critique Template on D2L for reference and fill it out. Please upload a PDF version to the submissions folder by the due date listed above.

Note Overview

After your [Peer] Notes Meeting, complete the Notes Overview template (available to download on D2L) using feedback on your feature-length screenplay from the instructor, workshop, self-evaluation and Peer Notes Meeting. These vetted concerns should be listed as bullet points under each category heading. Feel free to edit the headings to align with the notes you received and order them by priority. It is important to do a thorough job on this, as the Notes Overview will act as the foundation for your Rewrite Plan. You are expected to submit a PDF copy of the Notes Overview to D2L by the due date listed above.

Rewrite Plan

Complete the Rewrite Plan template (available to download on D2L). Each chart heading is broken into two categories (Concerns/Solutions). The concerns should be taken from your Note Overview assignment, broken into the appropriate categories, and then order by priority. Across from each concern, list possible solutions. The length of your Rewrite Plan will depend on the amount of work that needs to be done. Keep the cause-and-effect nature of cinematic storytelling in mind. You must consider the effect these alterations will have on the rest of the narrative. It is important to do a thorough job on this rewrite plan, as it will act as the foundation for your feature-length rewrite. Submit a PDF of the rewrite plan to D2L by the due date listed.

Rewrite Feature (Act 1, 2A, 2B, 3)

These are shorter benchmark assignments to track your progress and break the process down into more manageable chunks. Submit PDFs to D2L by the due date listed. Each submission is also required to include a revision log, tracking your progress.

Final Draft (Part 1: Pages 1-50, Part 2: Pages 50 - 90)

You are expected to submit your revised draft (minimum of 90 pages) by the due dates listed to the Submissions on D2L. A couple of things to keep in mind, as these assignments are worth a total of 55% of your final grade:

- Show don't tell. Show don't tell. Show don't tell. Show don't tell.
- Action description should be lean - only revealing what can be heard/seen onscreen.
- Avoid exposition-heavy dialogue - Always ask yourself, "Is there a way I can communicate this information visually?"
- Use your plot points as a guide.
- Use notes you received from the instructor, script workshops and coverage assignments to craft your revised draft
- The final version of your script should read as a marked improvement over your first effort.
- Characters, dialogue, structure and scene work should be completely reevaluated and enhanced.
- Spelling, grammar, and punctuation count - Proofread your work.
- Standard screenwriting formatting is required. Refer to Syd Field's Screenplay or The Hollywood Standard, the scripts we read in class, and your instructor for assistance
- Re-read your narrative for clarity - It may be a good idea to have a friend/family member look over the script as well.
- You must include a cover page
- Your submission must be at least ninety pages

CLASS POLICIES

Attendance/Participation:

Now that we are working remotely, your participation in the class is imperative. We will be working in groups, offering feedback, and discussing the writing process through a variety of online media. Not completing your peer feedback assignments or neglecting to log into class will result in a loss of the 10% participation grade.

Decorum and Civil Discourse:

Final Draft Screenplays, however, must be turned in by the assigned due date/time (the Final Draft deadline marks the official end of the course). Submissions by email will not be accepted. I also suggest backing up work with a Cloud file storage service, as computers crash.

Changes to Syllabus:

This syllabus is subject to change as necessary during the quarter. If a change occurs, it will be thoroughly addressed during class, posted under Announcements in D2L and sent via email.

Online Course Evaluations:

Evaluations are a way for students to provide valuable feedback regarding their instructor and the course. Detailed feedback will enable the instructor to continuously tailor teaching methods and course content to meet the learning goals of the course and the academic needs of the students. They are a requirement of the course and are key to continue to provide you with the highest quality of teaching. The evaluations are anonymous; the instructor and administration do not track who entered what responses. A program is used to check if the student completed the evaluations, but the evaluation is completely separate from the student's identity. Since 100% participation is our goal, students are sent periodic reminders over three weeks. Students do not receive reminders once they complete the evaluation. Students complete the evaluation online in CampusConnect.
