Course Description

This class focuses on practical ways to approach the rewriting process for feature film screenplays. Through group workshops and assignments, students isolate issues with plot, character development, dialogue and pacing in their script and work on addressing them in a full draft rewrite. Student must possess a complete feature length script in order to enroll in the course.

Objectives

Upon successful completion of this course students will be able to:

- organize and assess script feedback from their peers and the professor
- devise a detailed plan for a comprehensive rewrite
- revise their screenplay at a professional pace
- evaluate the work of their peers and formulate helpful feedback

Course Outcomes: Students will complete a rewrite plan and a full rewrite of an existing original feature screenplay.

Participation (In-Class + Notes)

You are expected to actively participate in the conversation every week as well as the workshops. For the workshops, you must thoroughly read all of your peers' submitted pages before class and formulate clear, supportive feedback that addresses:

- What worked for you/excited you in the submission
- Areas of potential concern you encountered
- Suggestions to address said concerns & any other story/character suggestions

You will deliver your notes on pages in class AND also upload written notes as responses to your peers' pages for your peers' reference and to prove to me you have read and considered the material.

Notes on the Evaluation of Student Work

Rubrics according to which written assignments are assessed will be available on D2L under Submissions. In order to obtain a desired grade on any assignment, students must review and adhere to these guidelines, which include not only the aforementioned expectations, but also mechanics (i.e. spelling, grammar, and punctuation). Please allow up to 7-10 days for the return of graded materials.

Late work will not be accepted without a valid excuse, and out of fairness to all, it cannot be workshoped in class.

In-Class Workshops

Feedback is essential to the writing process. As such, you will participate in weekly workshop sessions. Students will be divided into 2 groups. You must read and prepare notes before class on your peers' weekly submissions as made accessible to you on D2L under Discussions—this may include all students or only those submissions from a single group. Show your classmates the courtesy of reading their material as they should yours. Be truthful, but sensitive when giving notes. Be prepared to solve problems, not just point them out.

Decorum and Civil Discourse:

Please follow up with the instructor immediately if such a situation arises. Stories developed in class may involve issues such as hate and violence, but writing with a point of view that glorifies hate and violence will not be tolerated. Inclusion of individuals from the class in submitted creative materials will also not be tolerated.

Changes to Syllabus

This syllabus is subject to change as necessary during the quarter. If a change occurs, it will be thoroughly addressed during class, posted under Announcements in D2L, and students will be notified via email.

COVID-19 Health and Safety Precautions

Academic Integrity and Plagiarism

The university and school policy on plagiarism can be summarized as follows: Students in this course should be aware of the strong sanctions that can be imposed against someone guilty of plagiarism. If proven, a charge of plagiarism could result in an automatic F in the course and possible expulsion. (Note: Turnitin is used to check the originality of submissions on D2L.) The strongest of sanctions will be imposed on anyone who submits as his/her own work any assignment which has been prepared by someone else. Withdrawal

Withdrawals processed via this system are effective the day on which they are made. Retroactive Withdrawal
