Course Description

This course is designed to acquaint students with electronic privacy, security, and ethics. Students will gain an understanding of regulations impacting organizational security programs, cyber laws, and intellectual property laws, including their benefits and limitations. Ethical, societal, and legal issues with protecting privacy are evaluated. Students will explore real and potential security issues and steps that citizens, organizations, and governments can take to create environments of trust.

The type of instruction for this course is lecture and discussion.



Course Learning Outcomes

By the end of this course, students will be able to:

- Apply key provisions of major criminal, security, and privacy laws
- Produce written assessments of a current cybersecurity issues
- Analyze legal, societal, or ethical issues for multiple stakeholders
- Distinguish between different types of intellectual property laws
- Identify methods and privacy implications of online behavioral tracking

Assignment	Description	Grade Percentage
Class Participation	Participation in class discussions is measured in two ways. First, students are highly encouraged to ask questions and offer comments relevant to the day's topic. Participation allows the instructor to "hear" the student's voice and perspective. Secondly, students shall be called upon by the instructor to offer comments related to the reading assignments. Students must keep up with the reading to participate in class discussion.	10%
Attendance	Students are required to attend class meetings. These meetings are held every Tuesday, from 5:45 p.m. to 9:00 p.m. Students are expected to attend each class and to remain for the duration.	10%

Reading Summaries	A summary of the assigned week's reading is due by 4:00 p.m. of each Sunday before our Tuesday class. Summaries should be short and precise (500 words), accurately and briefly presenting the main ideas and issues of the reading.	40%
Quizzes	Responses to weekly discussions or quizzes are due prior to the conclusion of each class. Quizzes should be short and precise (300 words) and incorporate critical thinking skills. Details for each weekly assignment will be provided in class.	20%
Final paper	A single paper is due near the end of the course. The paper is on a cybersecurity topic of your choosing and involves reading outside sources and integrating those sources to present your topic. The paper should be at least 1500 words. Late papers are not accepted.	20%

Final Paper

Students are required to complete a final paper through the D2L course site. It will be checked electronically for plagiarism.

The final paper topic concerns the analysis of a current issue involving cybersecurity with respect to the topics covered in this course. The paper is on a topic of your choosing and involves reading outside sources and integrating those sources to present your topic. Late papers are not accepted.

Students must adhere to the following guidelines regarding the final paper:

- at least 1500 words
- double spaced
- grammatically correct with no misspellings or typos
- cite at least five outside sources
- late papers are not accepted

READING SUMMARIES

Students are required to submit a summary of the assigned week's reading by 4:00 p.m. of each Sunday before our Tuesday class using the Submissions tab in the D2L course site. Summaries are:

- short and precise (500 words)
- grammatically correct with no misspellings or typos
- accurately and briefly presenting the main ideas and issues of the reading

QUIZZES

Students are required to submit responses to weekly quizzes or discussion posts prior to the conclusion of each class at 9:00 p.m. using the Discussions tab in the D2L course site. Details for each weekly assignment will be provided in class. Discussion responses are:

- short and precise (300 words)
- grammatically correct with no misspellings or typos
- incorporate critical thinking skills
