Course Description:

This course focuses on completing the first draft of a feature-length screenplay. Emphasis will be placed on a foundation of character, structure, plot, and theme to bring the writer's vetted concept to fruition. The lectures, in-class workshops, and aggressive page deadlines are designed to culminate in a spec screenplay that showcases voice and command of screenwriting conventions. This feature length screenplay should be revised and polished in SCWR 303.

Prerequisites:

Course Outcomes:

Students will complete the first draft of a feature-length screenplay.

Learning Objectives:

Upon successful completion of this course students will be able to:

- demonstrate the ability to write at a professional pace
- write visceral and visual scenes that demonstrate a clear and unique voice
- create three-dimensional characters with unique voices and clear motivations
- apply established narrative techniques to scenes, sequences, and acts
- evaluate the work of their peers and formulate helpful feedback

Required Textbooks and Printed Resources:

None. Reading material will be provided by the instructor.

Screenwriting Software:

You will be required to use screenwriting software. [FINAL DRAFT](#), [FADE IN](#), [HIGHLAND](#), [WRITER'S DUET](#), and [CELTX](#) are options. Google Doc and Word templates exist, but they are terrible and will cause you more trouble than they are worth. WRITER'S DUET and HIGHLAND provide versions that are free for students. Screenwriting majors may be able to get a free copy of Final Draft from the school.

Course Management:

You will watch a feature film then write a sequence breakdown for that film in class.

Attendance:

Students are expected to attend every class and arrive on time. Each unexcused absence beyond the first equates to a loss of ten points from the student's final score.

Assignments:

Assignments should be submitted as PDF files to the appropriate submissions and discussions folders on D2L before class begins each week. Files should be saved as YourName.AssignmentName.PDF. Late work may not be workshopped in class.

Grading:

This course utilizes an approach known as “ungrading.” You will be awarded up to 40% of the total course points available for group and class participation, delivering completed assignments on deadline, and the final exam. Assignments will be deemed

complete at my discretion based on the stated parameters and expectations. The remaining 60% of the score will be determined by individual students themselves.

At the midpoint and the end of the quarter, students will be asked to reflect upon their performance and assign themselves a grade that represents the level to which they demonstrated professionalism and investment in the course, showcased techniques and ideas discussed in class, offered a unique take with a clear voice in their writing, challenged themselves to create a story that will be useful to them in their portfolio and matters to them personally, and responded to feedback.

Group Feedback scores will be given anonymously by your peers and will be the average of the score they each provide to me at the end of the quarter. This score will be based on the reliability and thoughtfulness of the written notes you provide on D2L and the contributions to group discussions that you make throughout the quarter. Class participation will be a reflection on your presence and engagement in full class discussions each week. I will update this score after every class session.

The instructor grades, group evaluation grade, and student self-evaluation grade will be combined to yield a final score. I reserve the right to raise a student-evaluation grade, but I will not lower a student-assigned grade once it has been delivered to me.

Withdrawal:

Students who withdraw from the course do so by using the [Campus Connection system](#). Withdrawals processed via this system are effective the day on which they are made. Retroactive Withdrawal:

This policy exists to assist students for whom extenuating circumstances prevented them from meeting the withdrawal deadline. During their college career students may be allowed one medical/personal administrative withdrawal and one college office administrative withdrawal, each for one or more courses in a single term. Repeated requests will not be considered. Submitting an appeal for retroactive withdrawal does not guarantee approval. College office appeals for CDM students must be submitted online via MyCDM. Incomplete:

An incomplete grade is a special, temporary grade that may be assigned by an instructor when unforeseeable circumstances prevent a student from completing course requirements by the end of the term and when otherwise the student had a record of satisfactory progress in the course. CDM policy requires the student to initiate the request for incomplete grade before the end of the term in which the course is taken. Prior to submitting the incomplete request, the student must discuss the circumstances with the instructor. Students may initiate the incomplete request process in MyCDM. All incomplete requests must be approved by the instructor of the course and a CDM Associate Dean. Only exceptions cases will receive such approval. If approved, students are required to complete all remaining course requirement independently in consultation with the instructor by the deadline indicated on the incomplete request form. By default, an incomplete grade will automatically change to a grade of F after two quarters have elapsed (excluding summer) unless another grade is recorded by the instructor. An incomplete grade does NOT grant the student permission to attend the same course in a future quarter.
