Course Description

This class focuses on practical ways to approach the rewriting process for feature film screenplays. Through group workshops and assignments, students isolate issues with plot, character development, dialogue and pacing in their script and work on addressing them in a full draft rewrite. Student must possess a complete feature length script in order to enroll in the course.

Prerequisite: None

Objectives

Upon successful completion of this course students will be able to:

- organize and assess script feedback from their peers and the professor
- devise a detailed plan for a comprehensive rewrite
- revise their screenplay at a professional pace
- evaluate the work of their peers and formulate helpful feedback

Course Outcomes: Students will complete a rewrite plan and a full rewrite of an existing original feature screenplay.

Course Management

Participation (In-Class + Notes)

ALL STUDENTS: You are expected to actively participate in weekly conversations and workshops. For workshops, you must read all your peers' submitted pages (as detailed in the course schedule) before class and formulate clear, supportive feedback that addresses:

- What worked for you/excited you in the submission
- Areas of potential concern you encountered
- Suggestions to address said concerns & any other story/character suggestions

You will deliver your notes on pages in class AND also upload written notes as responses to your peers' pages for your peers' reference and to prove to me you have read and considered the material.

SCWR 403 STUDENTS: Each 403 student will be placed in charge of a small group, which they will lead during weeks 2-4's group workshops as well as small group brainstorming workshops not listed in the syllabus that may be conducted any given week. 403 students will be expected to provide a type-written report on each workshop within the 48 hours following the session. All other specific expectations associated with this leadership role will be detailed at the beginning of the quarter for the benefit of all students.

Notes on the Evaluation of Student Work

Rubrics according to which written assignments are assessed will be available on D2L under Submissions. In order to obtain a desired grade on any assignment, students must review and adhere to these guidelines, which include not only the aforementioned expectations, but also mechanics (i.e. spelling, grammar, and punctuation). Please allow up to 7-10 days for the return of graded materials.

COURSE POLICIES

Late Work Policy

Late work will not be accepted for full points without a valid excuse, and out of fairness to all, it cannot be workshopped in class. Keep in mind that your peers need time to read each of your submissions, so treat all deadlines as hard deadlines. Any work that is submitted late without a valid excuse will receive a 50%-point deduction if submitted in the 24 hours following the deadline; after that the submission will receive a grade of zero, although students will still receive feedback from the instructor to facilitate the cumulative development of these assignments.

In-Class Workshops

Feedback is essential to the writing process. As such, you will participate in weekly workshop sessions. Students will be divided into 2 groups. You must read and prepare notes before class on your peers' weekly submissions as made accessible to you on D2L under Discussions—this may include all students or only those submissions from a single group depending on the assignment, so follow directions closely. Show your classmates the courtesy of reading their material as they should yours. Be truthful, but sensitive when giving notes. Be prepared to solve problems, not just point them out.

Decorum and Civil Discourse:

DePaul University is a community that thrives on open discourse that challenges students, both intellectually and personally, to be socially responsible leaders. It is the expectation that all dialogue in this course is civil and respectful of the dignity of each student. Any instances of disrespect or hostility can jeopardize a student's ability to be successful in the course. As this is a creative writing class, controversial subject matter may make its way into the conversation. Students have the right to express themselves artistically in their writing and address challenging issues. If you are uncomfortable with a conversation for personal reasons, you may be excused from the remainder of that class without penalty. Please follow up with the instructor immediately if such a situation arises. Stories developed in class may involve issues such as hate and violence, but writing with a point of view that glorifies hate and violence will not be tolerated. Inclusion of individuals from the class in submitted creative materials will also not be tolerated.

Changes to Syllabus

Retroactive Withdrawal
