I, _____ (name), am the parent/legal guardian of the minor child, _____ (name) (hereafter referred to as "my child"). I consent to my child's participation as an actor in the production of _____ (name of production) by DePaul University ("DePaul") on _____ (dates) (hereinafter the "Production"). This Release & Waiver covers the entirety of my child's participation in the Production, including travel to and from the Production.

I acknowledge that I am allowing my child to participate in the Production of my own free will. I acknowledge and appreciate that certain risks are inherent in participating in the Production. These risks include, but are not limited to, personal injury, illness, death, property damage, and property loss or theft, arising out of accidents, epidemics, disease, travel, acts of terrorism, civil disturbances and disorders, and the negligent acts or omissions of my child, myself or others (including DePaul and its agents and students).

I hereby grant DePaul, and those acting under its authority, the right and license to film and take photographs of my child in connection with the Production and to use my child's name, image, and likeness in all forms and media for all lawful purposes including, but not limited to, the Production, and internal and external DePaul communications. I understand that I or my child will not own any rights to the Production and I waive any opportunity and/or right to inspect or approve the Production or the use of my child's name, image, and likeness in the manner stated above.

I further acknowledge and agree that I will be present with my child at all times, including at all rehearsals and performances of the Production.

In consideration of my child participating in the Production, I personally assume on behalf of my child all of the risks in connection with the Production, whether foreseen or unforeseen.

I HEREBY RELEASE, WAIVE, DISCHARGE AND HOLD HARMLESS DEPAUL, ITS AFFILIATES, PREDECESSORS, SUCCESSORS, TRUSTEES, OFFICERS, MEMBERS, FACULTY, EMPLOYEES, STUDENTS, AGENTS, AND REPRESENTATIVES, PAST OR PRESENT (THE "RELEASED PARTIES") FROM ANY AND ALL CLAIMS, SUITS, LOSSES, LIABILITIES, JUDGMENTS, COSTS, FEES (INCLUDING ATTORNEYS' FEES) AND EXPENSES ("CLAIMS") FOR ANY PERSONAL INJURY, ILLNESS, EPIDEMICS, DISEASE, DEATH, PROPERTY DAMAGE, LOSS AND/OR THEFT OR ANY OTHER OCCURRENCE ARISING FROM MY CHILD'S PARTICIPATION IN THE PRODUCTION, WHILE MY CHILD IS TRAVELING TO OR FROM THE PRODUCTION, FROM ANY CLAIMS ARISING FROM OR RELATED TO THE POST-PRODUCTION USES OF THE PRODUCTION, AND THE USE OF MY CHILD'S NAME, IMAGE, OR LIKENESS IN CONNECTION WITH THE PRODUCTION, OR AS OTHERWISE DETAILED ABOVE.

I ALSO AGREE TO DEFEND, INDEMNIFY AND HOLD HARMLESS THE RELEASED PARTIES FROM AND AGAINST ANY CLAIMS ARISING FROM OR RELATED TO MY CHILD'S OR MY OWN ACTS OR OMISSIONS RELATING TO THE PRODUCTION, INCLUDING TRAVEL TO OR FROM THE PRODUCTION.

I enter into this Release & Waiver for myself, my child, my heirs, my assigns and my legal representatives.
