Course Description and Overview:

This course lays the foundation for successful improvisation in the current Chicago style, starting with the formation of the ensemble and exploring various elements of the creative process. Students experience what it means to be part of the greater whole, create freely without self-judgement, and develop tools of play that will make them better communicators and filmmakers.

This is an experiential class - meaning the skills are best learned in action. There will be discussion on the theory behind the fundamentals, but to learn creation one must...create. The environment is supportive, constructive, and playful, and feedback is often offered in real-time. We will put an emphasis on process as opposed to product, so while laughter is our currency, there is no pressure to "be funny." Instead, we will practice and develop skills in how to use this art form to explore the human condition through a series of theatrical exercises, scenes, and games. The approach will honor the original work developed by Viola Spolin while incorporating modern technique and perspective.

Learning Outcomes:

Upon completion, students will be able to:

- Understand the fundamentals of improvisation scene work as taught by Second City
- Recognize the building blocks of a comedic premise
- Demonstrate the ability to create collaboratively
- Employ the tools of Active Listening
- Execute the first beat of an improvised scene

Assignments (40% of final grade)

There are four written assignments that must be completed, each worth 10 points. They must be turned in before the next class begins. Late submissions will not be accepted. Documents must then be saved as a PDF and submitted to the corresponding D2L Dropbox link. If there is a communication or problem with D2L, please inform instructor immediately to rectify.

Attendance, Collaboration and Participation (30% of final grade)

Attendance has been covered. Collaboration is contingent to your commitment to the process and working successfully with your peers. Lack of participation is not acceptable. Sharing your voice by asking questions and supporting your peers during improvisation group work engages you in the process as an active participant. Negative, destructive, or disrespectful behavior toward the ensemble or individuals will result in a lowered grade. Feedback on these issues will be offered in real time.

Final Term Project (30% of final grade)

There are three components to your final project:

1. An in-class demonstration outlined by the instructor during week 10 (10 points)
2. Attendance at a Second City Touring Company show during Week 10 (10 points)
3. A written analysis of elements of Improvisation as reflected in the touring company show. The instructor will provide a list of prompts to guide the analysis, and may include some balance of objective observation and personal taste/point of view. This paper will be due the week of finals. (10 points)

Changes to the Syllabus

This syllabus is subject to change as necessary during the quarter. If a change occurs, it will be thoroughly addressed during class, posted under Announcements in D2L and sent via email.

Online Course Evaluations
