COURSE DESCRIPTION

This course is an introduction to the art of animation. Screenings, lectures, papers, readings, discussions, and personal animation projects designed to create an understanding and appreciation of the art of animation.

LEARNING GOALS

By the end of this course students can expect to have gained an understanding of: The principles and mechanics of animation

Animation terminology & techniques

The use of narrative strategies

How to analyze and interpret animated films

How to create short animated projects that incorporate basic principles of animation

Apply class experience to one's own work in terms of artistic expression

LEARNING DOMAIN DESCRIPTION

ANI 101: Animation for Non-Majors is included in the Liberal Studies program as a course with credit in the Arts and Literature domain. Courses in the Arts and Literature domain ask students to extend their knowledge and experience of the arts by developing their critical and reflective abilities. In these courses, students interpret and analyze particular creative works, investigate the relations of form and meaning and through critical and/or creative activity to come to experience art with greater openness, insight, and enjoyment. These courses focus on works of literature, art, theatre, or music as such, though the process of analysis may also include social and cultural issues. Students choose three courses from such choices as literature, the visual arts, media arts, music, and theater. No more than two courses can be chosen from one department or program.

LEARNING OUTCOMES

Students will be able to explain, in well-written prose, what a work of art is about and how it was produced (i.e. they should be able to articulate and explain the "content" of that work and its methodology of production).

HOW LEARNING OUTCOMES WILL BE MET

A number of short written reaction/response papers; one longer research or analysis paper (comparative or critical); readings; screenings; and a number of practical experience (or "lab") assignments.

HOW THE WRITING EXPECTATIONS WILL BE MET

For the short response/reaction papers, students will choose from a number of questions and/or topics and respond in writing. For the Final Paper, students will choose from the following: 1) Comparative Analysis Paper, the student compares two pieces of animation, or two animation styles or genres, or two animators, or two animation studios in terms of their social, cultural and aesthetic differences and similarities. 2) Critical Analysis Paper, the student makes an argument about a particular animation, style, genre, animation studio, or animator. 3) Research Paper, the student analyzes a perspective or argues a point, then backs up their thinking with others' ideas and information, complete w/ citations.

MATERIALS

Access to DePaul lab computers.

Optional - a personal computer that can run Adobe After Effects and Photoshop

Students will do several "lab" assignments using Adobe After Effects and Adobe Photoshop software. The Adobe suite of creative software is available in the student labs of the CDM building. In addition, students enrolled in ANI 101 will also have free access to the Adobe Creative Cloud for installation on their personal computer for the duration of the quarter.

Required - Smart phone (android or iPhone) with camera for Stop Motion Project

Optional - A tripod or grip for your smart phone

SOFTWARE
