Course Description:

Official: Graphical user interface development for web and desktop applications. Event-driven user controls. Development involves use of a visual integrated development environment (IDE). Prerequisite: IT 232

Detailed: Application development in C# of Console, Windows Presentation Foundation (WPF), server-side Web applications. The following technologies will be covered: Visual Studio, ASP.NET Web Forms, Entity Framework, WPF, XAML, XML/JSON.

- Students will be able create interactive Windows apps (Console, Web Forms, WPF, Windows 10)
- Students will be able to use Visual Studio
