Summary of Course

This course provides a Digital Cinema-specific capstone experience for the student. Students must have completed at least one of the three Topics in Production courses before they enroll in this course. The capstone course will connect the students' Digital Cinema course work with the University courses s/he has taken through three components: student-generated production packages, class/instructor discussions, and the actual creation/production of the student's proposed project.

The primary focus of the Screenwriting Concentration capstone is the completion of a first draft of a feature length screenplay or an original television series pilot that was outlined in FILM 397 Capstone Development.

Learning Domain Description

This course is designed to allow students to reflect on the learning derived from their undergraduate education (liberal studies, major and minor) in order to reach theory-based conclusions about self-identity, social relationships, liberal education, and future directions. They will also gather all production pieces and create a portfolio of their work.

Learning Outcomes

Students completing a Capstone course should be able to:

- Apply one or more theories or concepts from courses within their major to an analysis of a particular issue relevant to the major.
- Identify an idea, method, or concept from a discipline outside their major field of study and be able to apply it within the context of their major field of study.
- Examine how their previous coursework, including Liberal Studies courses, has contributed to their intellectual development and/or their post-graduation plans.

Writing Expectations

Students will be expected to complete a minimum of ten pages of writing for this course.

Assignments**Screenwriting Research Project (5% of Final Grade)**

Your group will present a 30-minute discussion on a screenwriting topic (Ex: dialogue, anti-hero leads, limited series, nonlinear techniques, serialized narratives, etc.). Draw upon your previous coursework, including Liberal Studies courses, and identify an idea, method, or concept from a discipline outside your major field of study to help formulate your position on your group's chosen topic. You may use video clips and script excerpts to illustrate to further illustrate your point. The project will be presented in-class before your first assigned group workshop:

- Group 1 – January 27th
- Group 2 – February 3rd
- Group 3 – February 10th
- Group 4 – February 17th

Career Plan Portfolio (10% of Final Grade)

There are two components to the Career Plan Portfolio outlined below. All documents should be saved as PDF files in a zip folder to the corresponding D2L Submission link by 11:59pm on Sunday, March 1st.

- Statement of Purpose – This document must clearly express your long-term goals in the film and television industry and the steps you plan to take in the next one to two years to accomplish these objectives. The paper must be a minimum of 3 pages.
- Resume – This one-page document should outline your most important experience, training, and accomplishments to date in the film and television industry.

Workshop (5% of Final Grade)

Feedback is an essential part of the writing process. To facilitate this, every student will have two in-class workshop sessions. (each session is worth 2.5 points). The initial workshop should focus on a 20-page excerpt from the first half of your Capstone Project and the following workshop should focus on a 20-page excerpt from the second half of your Capstone Project. You must send me the pages you would like to cover as a PDF via e-mail by 11:59pm on the Sunday before your assigned session.

Capstone Project Submission I (30% of Final Grade)

Capstone Project for students in the BFA in Film and Television Screenwriting Concentration majors consists of an original feature length screenplay or an original television series pilot & series bible. Capstone Project Submission II (40% of Final Grade)

Capstone Project for students in the BFA in Film and Television Screenwriting Concentration majors consists of an original feature length screenplay or an original television series pilot & series bible. The final submission of this assignment must be uploaded to the corresponding D2L Submission link by 2:30pm on Monday, March 16th. Late submissions will not be accepted.

Feature – A few things to keep in mind:

- You must include a cover page
- Your submission must be at least 90 pages and should read as a complete screenplay
- Spelling, grammar and punctuation count - Proofread your work, proofread it again and then proofread it one more time just to be sure.
- Standard screenwriting formatting is required.
- Don't wait until the last minute. It takes time to develop a solid narrative - You won't be able to do it in one night
- Please make sure the script is saved as a PDF

TV Series – A few things to keep in mind:

Series Bible

- The revised version of your series bible should consider the feedback you received from self-evaluation, instructor, and peers.
- The series bible must be a minimum of 5 pages
- While there is no fixed template for a series bible, it should include sections on the following: Overview, Themes, World, Characters, Season One Breakdown

Pilot

- The revised version of your pilot should consider the feedback you received from self-evaluation, instructor, and peers.
- One-hour pilot should be a minimum of 50 pages
- Half-hour pilot should be a minimum of 30 pages for single camera / 50 for multi-camera
- You must include a cover page
- Pilot must demonstrate the tone and world outlined in your series bible
- Spelling, grammar and punctuation count - Proofread your work, proofread it again and then proofread it one more time just to be sure.
- Standard screenwriting formatting is required.

Attitude

Online Course Evaluations

Withdrawal

Students who withdraw from the course do so by using the Campus Connection system (<http://campusconnect.depaul.edu>). Withdrawals processed via this system are effective the day on which they are made. Simply ceasing to attend, or notifying the instructor, or nonpayment of tuition, does not constitute an official withdrawal from class and will result in academic as well as financial penalty.

Retroactive Withdrawal

This policy exists to assist students for whom extenuating circumstances prevented them from meeting the withdrawal deadline. During their college career students may be allowed one medical/personal administrative withdrawal and one college office administrative withdrawal, each for one or more courses in a single term. Repeated requests will not be considered. Submitting an appeal for retroactive withdrawal does not guarantee approval.

College office appeals for CDM students must be submitted online via MyCDM. The deadlines for submitting appeals are as follows:

Excused Absence

Students must submit supporting documentation alongside the form. The professor reserves the sole right whether to offer an excused absence and/or academic accommodations for an excused absence.

Incomplete

An incomplete grade is a special, temporary grade that may be assigned by an instructor when unforeseeable circumstances prevent a student from completing course requirements by the end of the term and when otherwise the student had a record of satisfactory progress in the course. CDM policy

requires the student to initiate the request for incomplete grade before the end of the term in which the course is taken. Prior to submitting the incomplete request, the student must discuss the circumstances with the instructor. Students may initiate the incomplete request process in [MyCDM](#).

- All incomplete requests must be approved by the instructor of the course and a CDM Associate Dean. Only exceptions cases will receive such approval.
- If approved, students are required to complete all remaining course requirement independently in consultation with the instructor by the deadline indicated on the incomplete request form.
- By default, an incomplete grade will automatically change to a grade of F after two quarters have elapsed (excluding summer) unless another grade is recorded by the instructor.
- An incomplete grade does NOT grant the student permission to attend the same course in a future quarter.
