Course Description: This course is an introduction to the accessibility features in digital cinema that extend a film's reach to a wider audience, including foreign markets and consumers who are deaf, blind, or neurodiverse. Through hands-on exercises and project-based learning, students will grapple with how to translate the sensory world of film into rich descriptions for those who can't fully perceive the screen or hear the soundtrack. Along the way, students will engage with critical theory around disability aesthetics and access artistry. The course will culminate in the mounting of an accessible film event that is open to the public. Strong writing skills and basic familiarity with film editing techniques are highly recommended.

POST 110 is a prerequisite for this class.

Learning Outcomes: By the end of this course students will be able to:

- Understand the vital role of translation and accessibility in the distribution of films and media
- Anticipate the access needs of a global and diverse audience that includes foreign, deaf and blind consumers
- Learn the fundamental post production skills needed to translate, subtitle, dub, caption, and describe various media

Withdrawal

Retroactive Withdrawal
